

**Public Meeting #1 Q&A**

**Q-Will there be a path connecting the wash path to the new rec center?**

A-Yes, there will be pathways connecting the user to the new Recreation Campus, as well as other amenities and stores around town!

**Q-Is the idea to mimic the wash as it exists to the north of McDowell?**

A-Bullard Wash I and II are located north of McDowell Road where the wash doubles as linear park with walking paths. Unfortunately, the current funding does not include creating a park. It will include paths/trails alongside the unimproved Bullard Wash

**Q-Will it include parking to access it from different points?**

A-Yes! During the master planning process, parking locations will be identified along the corridor.

**Q-Will we still have flowing water South of Yuma Rd?**

A-Yes, the flow of the drainage will not change.

**Q-Will the trail be marked to separate bicycle traffic from pedestrian traffic? Such as a stripe down the middle?**

A-This will be determined as the project progresses. Feedback from the public during the public meetings will help to determine what the final path/trail will look like.

**Q-Will the path be paved? Will it be landscaped?**

A-This will be determined as the project progresses. Feedback from the public during the public meetings will help to determine what the final path/trail will look like.

**Q-How wide on either side of the Bullard Wash will this corridor expand?**

A- This will be determined as the project progresses. Feedback from the public during the public meetings will help to determine what the final path/trail will look like.

**Q-What is the plan to connect to other trails N, E, and W of this segment?**

A-There will be connection points throughout the trail that will allow the user to transition to other trails in the area.

**Q-Will the project include any restrooms, drinking water, or picnic areas?**

A-Yes! This will be determined as the project progresses. Feedback from the public during the public meetings will help to determine what the final path/trail will look like.

**Q-What is the plan for traversing major streets, like bridges, underpass, tunnel, or ??**

A-The design team is evaluating all options including pedestrian bridges and underpasses to allow safe crossing of major roadways.

**Q-What is the project timeline?**

A-The project is in the master plan phase right now. The final plan will be presented to Council in May or June of 2021. The next phase of design and construction has not been funded and there is no timeline as of now.

**Q-what are your plans for lighting?**

A- This will be determined as the project progresses. Feedback from the public during the public meetings will help to determine what the final path/trail will look like.

**Q-Will it be fully ADA accessible?**

A-Yes! The future trail will meet all ADA requirements.

**Q-Is this project fully funded? Are there other projects competing for the same funding that may limit or even eliminate this project?**

A-The master plan study is fully funded. There are no competing projects as the funding for master planning has been identified and secured. Staff will seek grants for future funding for design and construction.
