

RESOLUTION NO. 2024-2393

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, SUPPORTING THE SUBMISSION OF 2024 GRANT APPLICATIONS BY ALICE COOPER'S SOLID ROCK TEEN CENTERS, ALL FAITH COMMUNITY SERVICES, ARIZONA COMMUNITY IMPACT, G.A.S.K.I.N.S. CHARITY, NEW LIFE CENTER, AND SOUNDS OF AUTISM TO GILA RIVER INDIAN COMMUNITY AND AUTHORIZING THE CITY MANAGER TO ACCEPT AND ADMINISTER SUBSEQUENT AWARDED FUNDS, AND ANY AMENDMENTS THERETO, AS A PASS-THROUGH GRANT.

WHEREAS, Arizona's Indian Gaming Compact provides that an Indian Tribe make twelve percent (12%) of its net annual State contributions to cities, towns, or counties for government services that benefit the general public; and

WHEREAS, private, not-for-profit organizations wishing to access Indian Gaming Funds ("Gaming Funds") to provide public benefits must secure sponsorship from a city, town, or county before making application; and

WHEREAS, this sponsorship must be expressed in a resolution passed by the local government sponsor; and

WHEREAS, Alice Cooper's Solid Rock Teen Centers desires to submit an application for \$30,000 to support music lessons and mental health improvement; and

WHEREAS, Arizona Community Impact desires to submit an application for \$74,500 to support their Capacity to Connect program; and

WHEREAS, All Faith Community Services desires to submit an application for \$10,000 to support emergency programs facility enhancement; and

WHEREAS, G.A.S.K.I.N.S. Charity desires to submit an application for \$50,000 to support the Simple Home Technology program for low-income households in Goodyear; and

WHEREAS, New Life Center desires to submit an application for \$50,000 over two years to support the emergency shelter; and

WHEREAS, Sounds of Autism desires to submit an application for \$60,000 over three years to support their operational budget

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The City Council supports these grant requests for funding.

SECTION 2. The City Manager is hereby authorized to accept and administer subsequent awarded funds, and any amendments thereto, as a pass-through grant. The City of Goodyear makes no guarantees beyond disbursement of funding to the non-city recipient. Upon the City of Goodyear's distribution of the awarded funds to the non-city recipient, the City of Goodyear shall be considered released from any and all claims, demands, debts, liabilities, or obligations that may arise in

the event that the non-city recipient fails for any reason to expend the awarded funds in accordance with their grant application to the Gila River Indian Community.
