RESOLUTION NO. 2024-2400

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR FEDERAL FY 2024 SAFE STREETS AND ROADS FOR ALL (SS4A) DISCRETIONARY PROGRAM FUNDS TO THE U.S. DEPARTMENT OF TRANSPORTATION, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING TO SAID APPLICATION, AND AUTHORIZING THE CITY MANAGER TO EXECUTE A GRANT AGREEMENT (IF GRANT FUNDS ARE AWARDED), AND AUTHORIZING THE CITY MANAGER TO APPROVE THE REQUIRED BUDGET TRANSFER (IF GRANT FUNDS ARE AWARDED).

WHEREAS, there were 33 roadway fatalities occurred in Goodyear in 2017-2021; and

WHEREAS, the City of Goodyear City Council is committed to reach zero roadway fatalities and serious injuries by 2040; and

WHEREAS, it is in the best interest of the City to apply for Safe Streets and Roads for All (SS4A) discretionary Program grant funds to conduct a comprehensive safety action plan and associated demonstration project to support the achievement of that goal; and

WHEREAS, the projects qualify as eligible projects under the SS4A program; and

WHEREAS, the resources for the 20% match requirement will be identified following adoption of the FY2024-2025 budget; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- SECTION 1. The City Manager, or her designee, is hereby authorized to submit an application to the U.S. Department of Transportation for the SS4A program to conduct a comprehensive safety action plan and associated demonstration project for an amount not to exceed \$650,000.
- SECTION 2. If the grant application is awarded, the City will enter into a Grant Agreement with the U.S. Department of Transportation to implement the projects or programs that have been approved by the U.S. Department of Transportation.
- SECTION 3. The City Manager is hereby authorized to execute all documents relating to these applications and any grant offer resulting from such applications.
- SECTION 4. If grant funds are awarded to the City of Goodyear, the City Council hereby approves necessary budget transfers in the amount of the awarded funds.
