A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AUTHORIZING THE SUBMISSION OF THREE APPLICATIONS FOR STATE SHARED REVENUE GRANT PROGRAM REQUESTING EDUCATION, PUBLIC SAFETY, AND CULTURAL & ENVIRNONMENTAL DEVELOPMENT AND PROTECTION FUNDS FROM THE TOHONO O'ODHAM NATION, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING TO SAID APPLICATIONS, AND AUTHORIZING THE CITY MANAGER TO EXECUTE A GRANT AGREEMENT (IF GRANT FUNDS ARE AWARDED), AND AUTHORIZING THE CITY MANAGER TO APPROVE THE REQUIRED BUDGET TRANSFER (IF GRANT FUNDS ARE AWARDED).

WHEREAS, the Tohono O'odham Nation shares a portion of their revenues from tribal gaming directly with local governments to benefit the general public through direct distribution of funding; and

WHEREAS, it is in the interest of the City to apply for these funds to aid Mobile Elementary School District No. 86 in the construction and installation of improved security fencing; and

WHEREAS, it is in the interest of the City to apply for these funds to expand its fleet of public safety drones; and

WHEREAS, it is in the interest of the City to apply for these funds to provide diverse arts and culture events that serve all ages, abilities, and interests through the Art Pop Ups in the Park initiative; and

WHEREAS, these projects align with the funder's priority areas; and

WHEREAS, there is no match requirement for this application; and

WHEREAS, it is the intent to accept any awarded funds and to use them in accordance with the application.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- The City Manager, or her designee, is hereby authorized to submit applications to the Tohono O'odham Nation for an amount of \$120,000 to aid Mobile Elementary School District No. 86 in the construction and installation of improved security fencing, \$151,000 to expand its fleet of public safety drones, and \$25,000 to provide diverse arts and culture events that serve all ages, abilities, and interests through the Art Pop Ups in the Park initiative.
- SECTION 2. If the grant application is awarded, the City will enter into an agreement with the Tohono O'odham Nation to implement the projects or programs that have been approved by the funder.
- SECTION 3. The City Manager is hereby authorized to execute all documents relating to these applications and any grant offer resulting from such applications.

SECTION 4. If grant funds are awarded to the City of Goodyear, the City Council hereby approves necessary budget transfers in the amount of the awarded funds.
