A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION FOR THE GENERAL PLAN HELD ON MAY 21, 2024; DECLARING THE RESULTS OF THE VOTE ON THE GENERAL PLAN 2035: GROWING GOODYEAR, PLANNING OUR FUTURE QUESTION; ORDERING THE CITY CLERK TO RECORD THIS RESOLUTION; AND SETTING AN EFFECTIVE DATE.

WHEREAS, on November 13, 2023, the city of Goodyear City Council adopted Resolution 2023-2359, calling for a Special Election and submitted a question to the voters to adopt the General Plan 2035; and

WHEREAS, the city of Goodyear held a Special Election on Tuesday, May 21, 2024, for the purpose of determining if the General Plan 2035 was adopted; and

WHEREAS, the election returns have been presented to, and have been canvassed by, the Goodyear City Council; and

WHEREAS, A.R.S. §16-642(A) requires that the governing body shall hold a meeting to adopt a canvass of the result of the election not less than six days nor more than twenty days following the election.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- SECTION 1. The total number of votes cast at said Special Election was 13,497. The total number of registered voters was 58,326. (Exhibit A)
- SECTION 2. The total number of rejected and late ballots was 228. (Exhibit B)
- SECTION 3. The total number of provisional ballots was 0 with 0 being rejected and 0 accepted. (Exhibit C)
- SECTION 4. The results of the Special Election having been determined, the number of yes and no votes is as follows:
