THE ABANDONMENT AND THE RESOLUTION.

## RESOLUTION NO. 2024-2415

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, DECLARING SECTIONS OF 175<sup>th</sup> AVENUE AND ELWOOD STREET UNNECESSARY FOR PUBLIC ROADWAY AND VACATING THE ROADWAY; PROVIDING FOR THE RECORDATION OF THE RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATES OF THE ABANDONMENT AND THE RESOLUTION.

WHEREAS, WHEREAS, in 1987 AMCOR Investments, a California corporation conveyed to the City of Goodyear by Quit Claim Deed recorded in the official records of the Maricopa County, Arizona Recorder as Instrument No. 1987 0196721 property for sections of what was to be developed as South 175<sup>th</sup> Avenue and W. Elwood Street (formerly Dunlap); and

WHEREAS, the city received an application to abandon the portion of the property conveyed for S. 175<sup>th</sup> Avenue and W. Elwood Street (formerly Dunlap) as more particularly described in Exhibit "A" attached hereto and incorporated herein (the "Abandonment Area"); and

WHEREAS, the Abandonment Area has not been used as a public right-of-way, and no street improvements have been constructed within the Abandonment Area; and

WHEREAS, City engineering staff has confirmed that the Abandonment Area is not needed for public right-of-way; and

WHEREAS, Owner provided the city received utility clearances confirming there are no existing public utilities within the Abandonment Area; and

WHEREAS, pursuant to A.R.S. § 28-7202, the Mayor and Council of the City of Goodyear are vested with the power to determine and find that a public roadway or portion thereof is unnecessary for public use as a roadway; and

WHEREAS, the Mayor and Council of the City of Goodyear find and determine that the portion of S. 175<sup>th</sup> Avenue and W. Elwood Street alignments described in Exhibit "A" is unnecessary for public roadway purposes; and

WHEREAS, the market value of the City's interest in the property legally described and depicted in Exhibit A is nominal and the City will receive consideration for the abandonment of such interests in the form of tax revenues gained by the development of the adjacent property, the elimination of the City's responsibility for such rights-of-ways and relief from potential liability for property damages, injury or death that may occur in the abandoned public roadway.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

SECTION 1. The Mayor and Council of the City of Goodyear find and determine that the portion of the S. 175<sup>th</sup> Avenue alignment and the W. Elwood Street alignment, as more particularly described Exhibit "A" attached hereto and incorporated herein by reference is unnecessary for public roadway purposes and is hereby vacated pursuant to A.R.S. § 28-7205.


SECTION 2. The public roadway shall be vacated as provided for in Section 1 and this vacation shall become effective upon the recordation of this Resolution 2024-2415 and Exhibit A attached hereto with the office of the County Recorder for Maricopa County, Arizona.

SECTION 3. Pursuant to A.R.S. § 28-7205, title to the property being vacated and abandoned herein shall vest, subject to all existing encumbrances, liens, limitations, restrictions and estates, to the owners of record of the land abutting the property as more particularly described in Exhibit "A" attached hereto and incorporated herein by this reference as of the date this Resolution is recorded.

SECTION 4. The City Clerk shall record this Resolution 2024-2415 and Exhibit A attached hereto with the office of the County Recorder for Maricopa County, Arizona within ten (10) days of the effective date of this Resolution.

SECTION 5. Resolution 2024-2415 shall be effective upon the date of its adoption by the Mayor and Council of the City of Goodyear.

LEGAL DESCRIPTION FOR  
EL CIDRO  
RIGHT-OF-WAY ABANDONMENT

That part of Section 23, Township 1 North, Range 2 West, of the Gila and Salt River Meridian, Maricopa County, Arizona, more particularly described as follows:

Commencing at the Cotton Picker Spindle marking the West Quarter Corner of said Section 23, from which the Maricopa County Department of Transportation Brass Cap in a hand hole marking the Southwest Corner of said Section 23 bears South 00°11'46" West, a distance of 2,636.39 feet;

Thence South 89°43'14" East, along the North line of the Southwest Quarter of said Section 23, a distance of 2,585.78 feet to the True Point of Beginning;

Thence continuing South 89°43'14" East, along said North line, a distance of 65.00 feet to the calculated Center of said Section 23;

Thence North 00°12'45" East, along the West line of the Northeast Quarter of said Section 23, a distance of 20.13 feet to a point on a 470.00 foot radius non-tangent curve, whose center bears South 12°17'35" East;

Thence Easterly, departing said West line and along said curve, through a central angle of 12°33'11", a distance of 102.97 feet;

Thence South 89°44'24" East, a distance of 206.43 feet;

Thence South 44°44'24" East, a distance of 28.28 feet;

Thence South 89°44'24" East, a distance of 50.00 feet;

Thence North 45°15'36" East, a distance of 28.28 feet;

Thence South 89°44'24" East, a distance of 404.16 feet to the beginning of a tangent curve of 470.00 foot radius, concave Northerly;

Thence Easterly, along said curve, through a central angle of 10°00'00", a distance of 82.03 feet;

Thence South 79°44'24" East, a distance of 69.87 feet;

Thence South 36°30'34" West, a distance of 95.96 feet to a point on a line which is parallel with and 65.00 feet Southerly, as measured at right angles, from the North line of the Southeast Quarter of said Section 23;

Thence North 89°43'14" West, along said parallel line, a distance of 831.36 feet to a point on a line which is parallel with and 65.00 feet Easterly, as measured at right angles, from the West line of said Southeast Quarter;

Thence South 00°12'45" West, along last said parallel line, a distance of 1049.24 feet;

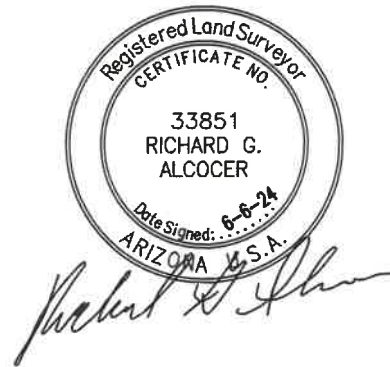
Thence South 41°24'30" West, departing said parallel line, a distance of 98.69 feet to a point on said West line;
