#### **RESOLUTION NO. 2024-2422**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, ESTABLISHING PUBLIC RIGHT-OF-WAY REQUIRED FOR THE INSTALLATION OF A TRAFFIC SIGNAL AT THE INTERSECTION OF SOUTH COTTON LANE AND WEST ELWOOD STREET; PROVIDING FOR AN EFFECTIVE DATE AND RECORDATION.

WHEREAS, pursuant the power vested in the city of Goodyear ("City") by its Charter and pursuant to A.R.S. § 9-276, the Mayor and Council of the City of Goodyear have the power to establish, construct, improve, regulate vacate, modify roadways open to the public; and

WHEREAS, the City of Goodyear owns certain real property generally located at the northwest corner of S. Cotton Lane and W. Elwood Street, which was acquired by Special Warranty Deed, recorded on December 28, 2007, in instrument 2007-1356154 ("City Property"); and

WHEREAS, the City will be installing a traffic signal at the intersection of S. Cotton Lane and W. Elwood Street as part of Capital Improvement Project #42063 S. Cotton Lane and W. Elwood Street Traffic Signal Improvements ("Project"); and

WHEREAS, traffic infrastructure improvements are to be located within public right-of-way, and in order to complete the Project, a portion of the City Property, legally described and depicted in Exhibit "A" attached hereto, must be declared a public right-of-way; and

WHEREAS, it is in the best interest of the public for the portion of the City Property described and depicted in Exhibit "A" attached hereto to be declared as public street.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:

- The Mayor and Council of the City of Goodyear find and determine that the public health, safety, and welfare of the City require that the portion of City Property more particularly legally described and depicted in Exhibit "A," attached hereto and incorporated herein by this reference, be formally declared as public right-of
  - way.
- SECTION 2. The Mayor and Council of the City of Goodyear, on behalf of the City of Goodyear, an Arizona municipal corporation, as owner of that real property more particularly described and depicted in Exhibit "A" attached hereto and incorporated herein by this reference and declared as public right-of-way to be
  - maintained by the City of Goodyear.
- This Resolution 2024-2422 shall become effective on the date it is passed and adopted by the Mayor and Council of the city of Goodyear. The City Clerk shall cause a certified copy of this Resolution, including Exhibit A, to be recorded in the official records of the Maricopa County Recorder.


