

RESOLUTION NO. 2024-2424

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, RATIFYING THE CONDITIONAL APPROVAL AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR THE 2024 ASSISTANCE TO FIREFIGHTERS GRANT (“AFG”) REGIONAL GRANT AWARD, TO THE GLENDALE REGIONAL FIRE DEPARTMENT ON BEHALF OF WEST VALLEY CITIES, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS RELATING TO SAID APPLICATION, AND AUTHORIZING THE CITY MANAGER TO EXECUTE A GRANT AGREEMENT (IF GRANT FUNDS ARE AWARDED), AND AUTHORIZING THE CITY MANAGER TO APPROVE THE REQUIRED BUDGET TRANSFER (IF GRANT FUNDS ARE AWARDED).

WHEREAS, on July 16, 2024, the Mayor granted conditional approval to accept a portion of a grant award from the 2024 Assistance to Firefighters Grant Regional Grant through FEMA for assistance in regional education and development training for all west valley cities, contingent upon approval by the Goodyear City Council by resolution; and

WHEREAS, the resources for the 10% match requirement in the amount of \$28,533 have been identified and are available in the goodyear fire department’s budget; and

WHEREAS, the pursuit of this grant is to the benefit of the citizens of the City of Goodyear.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF GOODYEAR, MARICOPA COUNTY, ARIZONA, AS FOLLOWS:


SECTION 1. Ratify the current application submission for the 2024 Assistance to Firefighters Regional Grant, for west valley regional education and development training for an amount not to exceed \$28,533.

SECTION 2. If the grant application is awarded, the city will enter into a Memorandum of Understanding (“MOU”) for the 2024 Assistance to Firefighters Grant Regional Grant Award with Glendale Regional Fire Department to implement the programs that have been approved by FEMA.

SECTION 3. The City Manager is hereby authorized to execute all documents relating to this application and any grant agreement offered as a result of grant funding.

SECTION 4. If grant funds are awarded to the City of Goodyear, the City Council hereby authorizes the City Manager to approve the necessary budget transfers in the amount of the awarded funds.
